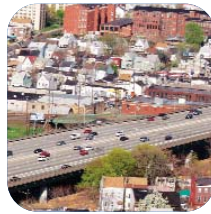

We also work with our members to improve the accessibility and affordability of European national land and geographic information, and have a network of value-added resellers to reach a variety of sectors, including transport, geo-marketing, asset and environmental management, and regional development.

We are already working with the European Commission in projects such as the Global Monitoring for Environment and Security programme and with Eurostat and the European Environment Agency. We are also a respected member of a number of international organisations including the UN Working Party on Land Administration and the Global Spatial Data Infrastructure.

## Our vision for cadastre and land registry

More than half of EuroGeographics' members are responsible for developing and maintaining land registers and national cadastres, a system that records parcels of land and information about it. These are an integral part of both national and international geographical information infrastructures and a vital component in the infrastructure which integrates Europe's geographical information. They form the backbone of land administration and the property market by providing the link between legal, environmental, land use, valuation, agricultural and zoning information.

### State-of-the-art services for property and land information

EuroGeographics group of land registry and cadastre experts is working to provide state-of-the-art services for the diverse range of users in property and land information markets. These include policy makers and those from the environmental, housing, transportation, agriculture and tourism sectors. The members are also playing an important role in building the pan-European geographical information infrastructure which will standardise their national data so that it works in harmony with that of other countries.

### A vision to meet e-government, technical and political changes

Open property markets are vital to the development of the European economy and will, in the future, demand that all relevant information and transactions take place in electronic form, in one place, online. Our members recognise the crucial role they play in providing reliable property data, facilitating cross-border sales and mortgages, and upholding the right of citizens across Europe to have their assets secured and formalised. They also want to share knowledge and expertise with their counterparts in countries with developing economies.

### The aim is that by 2012 European Cadastre and Land Registry organisations will:

- Establish networks to create one-stop service portals for electronic information and government services
- Ensure that land register and cadastre registration documents can be submitted in electronic form quickly and cost-effectively by both professionals and, where relevant, the public. Fees and duties will also be payable online
- Help to make relevant information available for value-added public and private services, provided that it does not infringe upon rights to privacy
- Anticipate and respond to new user requirements such as demands for information about what lies below or above the earth's surface
- Support legislation and technology to enable secured mortgage lending across national borders
- Participate in pan-European land and property information projects enabling cross-border property transactions
- Encourage the establishment of partnerships.
